- 9. You are reminded that the record plans and/or test reports required under this approval should be submitted within the time frame as specified in the attached appendix/appendices. Delay in the submission of the required documents may affect the timely processing of Form BA14 and/or occupation permit applications.

To facilitate the carrying out of minor amendment works during the construction process, you are advised to apply for modification to Building (Administration) Regulation 33(1) in respect of minor amendments to the above approved works either after obtaining the consent or simultaneously with the application for consent to the commencement of the said works. Your attention is drawn to paragraphs 20 & 22 of PNAP ADM-19.

11. Upon the completion of the construction of the cantilevered slab canopy, you are reminded as Registered Structural Engineer for the works to liaise with the Authorized Person and the Registered General Building Contractor/Registered Specialist Contractor to prepare documentation on the inspection and maintenance of the cantilevered slab canopy, for regular maintenance and repair to be arranged by the Incorporated Owners/management company. Routine inspection and maintenance works such as cleaning of clogged drain pipes and drainage channel, and inspection of waterproofing systems and finishes should be carried out regularly and particularly

during the rainy seasons.

14. To promote green environment and facilitate effective preparation and processing of structural submissions, you are encouraged to submit Part II structural calculations in CD/DVD format in accordance with PNAP ADM-8 for the superstructure plans.
