Matters to Note

[Note 1]

This form is applicable only if the event under TPPEL application involving the temporary structure(s) with submission of structural justifications. If the application is found in order, a Schedule of PTS (Form PTS 2) will be returned to the applicant. Applicant who intends to reuse/re-erect PTS at the pre-accepted location(s) in future TPPEL applications should submit the following documents for Building Authority's processing:

- (a) a safety certificate via Form PTS 3 duly completed by an authorized person/registered structural engineer; and
(b) a layout plan with the PTS registration number(s) clearly marked against the proposed temporary structures.

Any person making a false declaration or misrepresenting a material fact shall be guilty of a criminal offence and subject to prosecution.

A. Personal Data

Purposes of Collection

- The personal data provided by means of this form will be used by the Buildings Department for the following purposes:
 - activities relating to the processing of your application in this form;
 - activities relating to the above proposed works, and administration of the Buildings Ordinance and other legislations; and
