Reply:

Apart from responding to reports, the Buildings Department (BD) has been taking enforcement actions against illegal domestic use in industrial buildings (IBs) in an orderly and systematic manner through large scale operations (LSOs) since April 2012. Such enforcement actions against illegal domestic use in IBs may involve subdivided flats (SDFs).

Information on the numbers of premises (including SDFs) inspected, discontinuation orders issued, prosecutions instigated against non-compliance with discontinuation orders, premises where closure orders were applied from the court and premises where government contractors were arranged to rectify the irregularities in the past three years are tabulated below –
