Use of Fire Retardant Protective Net/Screen/Tarpaulin/Plastic Sheeting on Facade of Buildings under Construction, Demolition, Repair or Minor Works

On 18 October 2025, a No. 3 alarm fire involving bamboo scaffolds broke out at the facade of a building under alteration, addition and minor works causing several casualties.

- 2. To ensure safety of buildings and building works, I call on you, registered building professionals and registered contractors, to take immediate action to inspect and ascertain that the protective net, screen, tarpaulin and plastic sheeting installed at the facade of buildings with works under your charge (including any sites under construction, demolition, repair and minor works) possess the appropriate fire retardant properties in compliance with the recognised standards to prevent the spread of fire should a fire occur. Your attention is drawn to the relevant requirements contained in:

- 3. The BD is committed to upholding the safety of buildings and building works. If it is discovered that building works being carried out involve the use of protective net, screen, tarpaulin and plastic sheeting with inadequate fire retardant properties, the BD will take appropriate actions against the relevant persons and contractors under the Buildings Ordinance, including the consideration of instigating prosecution and disciplinary actions.
