## **Electronic Certificates of Registration for** Registered Building Professionals and Registered Contractors

I am pleased to inform you that for registration applications submitted on or after 30 June 2022, the Buildings Department (BD) will issue certificates of registration under the Buildings Ordinance in electronic form (e-Certificate) to the applicants via email. BD will also issue the registration cards to the applicants who are Registered Inspectors (RI) and Registered Minor Works Contractors (Individual) (RMWC(Ind)).

- 2. A OR code linking to the e-Certificate holder's registration information (i.e. name, registration number and date of expiry of the registration) in BD website will be printed on the e-Certificate and the registration card for ease of reference.
- The QR code will also be shown on the QP cards for Qualified Persons. 3.
- Samples of the certificate of registration and the registration card for RI and RMWC(Ind) and the OP card for Qualified Persons are attached for your reference.
- For the avoidance of doubt, the certificates of registration already issued by BD are still valid up to the date of expiry of registration.
