## Regular Inspection and Maintenance of Large Metal Gates

A fatal work accident involving a large electric gate happened on 15 August 2022.

For the sake of public safety, I call on you, property managers, to take immediate action to inspect all large electric gates at the properties under your management, in particular devices with a manual mode, to ensure that they can be safely operated manually, so as to prevent recurrence of similar accidents. Your attention is drawn to the relevant information contained in:
