


Buildings Ordinance, Cap 123
Specified Forms

In exercise of the powers under section 22(4) of the Buildings Ordinance, I have specified the forms listed at Appendix A.

2. Where a section of the Buildings Ordinance or a Regulation requires an application, a notice or a certificate to be submitted in a specified form, the form listed in Appendix A for the relevant purpose should be used and should not be altered or amended in any way. Failure to use the specified form may invalidate the application, notice or certificate.

3. The specified forms will be kept under regular review and revised as necessary. The most updated versions of the specified forms as well as the list at Appendix A can be obtained by downloading from the website of the Buildings Department (www.info.gov.hk/bd) or from the reception counter on 12/F of Buildings Department's headquarters at Pioneer Centre, 750 Nathan Road, Kowloon during office hours.
