Summary of Decisions of the Building Committee Building Committee I 45/2012 held on 20.11.2012

(a) <u>BCI 1 45/2012</u>

Issue : Non-provision of service lane.

Decision : The committee noted that there was no existing lane in the vicinity and

that a lane pattern would unlikely be created in future. Having considered the layout of the sites in the vicinity, the committee

accepted the proposed non-provision of service lane.

(b) BCI 2 45/2012

Issue : Application for flexible application of domestic site coverage under

PNAP APP-132.

Decision : Noting that the proposal was in compliance with the criteria set out in

PNAP APP-132, the committee agreed to the granting of modification

to permit flexible application of site coverage.

(c) BCI 3 45/2012

Issue : (i) Exclusion of voids over living/dining rooms of duplex units

from GFA calculation.

(ii) Exclusion of the rainwater recycling plant room from GFA

calculation.

Decision : (i) Having studied the design, the committee agreed to the

proposed exclusion of the voids from GFA calculation in line

with PNAP APP-2.

(ii) Having considered the design and the function of the system,

the committee agreed to exclude the plant room from GFA

calculation under B(P)Reg 23(3)(a).

(d) BCI 4 45/2012

Issue : Site area for PR and SC calculations.

Decision : Having considered the circumstances of the case, the committee

agreed that the actual site area based on land survey records should be

adopted for PR and SC calculations.

(e) BCI 5 45/2012

Issue : Exclusion of party structures and common staircases of a demolished

building from GFA and site coverage calculations.

Decision : Having considered the proposal, the committee did not agree to the

proposed exclusion of party structures and common staircases from

GFA and site coverage calculations.

(f) <u>BCI 6 45/2012</u>

Issue : Inclusion of lane in site area.

Decision : Having studied the proposal, the committee did not agree to the

inclusion of the set back rear lane in site area.

(g) <u>BCI 7 45/2012</u>

Issue : (i) Exclusion of vertical green walls from GFA and site coverage

calculations.

(ii) Non-provision of service lane.

Decision : (i) Having studied the design, the committee did not agree to the

exclusion of the vertical green walls from GFA and site

coverage calculations.

(h) BCI 8 45/2012

Issue : A&A proposal involving the reconstruction of main walls of an

Issue : Exclusion of covered areas of an air-conditioning system from GFA

calculation.

Decision : Having studied the proposal, the committee agreed to disregard the

covered areas of the proposed air-conditioning system from GFA

calculation.
