in line with paragraph 15(b)(vii)(4) of PNAP APP-2.

Issues (i) Exclusion of voids in single-family houses from GFA

calculation.

(ii) Exclusion of rainwater recycling plant room from GFA

calculation.

Decisions Noting that the criteria set out in Appendix A to PNAP APP-2 (i)

were complied with, the committee agreed to exclude the voids

from GFA calculation.

(ii) Having considered the design and the function of the proposed

rainwater recycling system, the committee agreed to exclude

the rainwater recycling plant room from GFA calculation.

(d) BCI 4 21/2013

(ii)

Extinguishment, building over and inclusion in site area of an Issue (i) existing lane with the provision of a diversionary lane.

Inclusion of the proposed diversionary lane in site area.

Decision (i) Noting that the existing lane in question was not a required

> lane under the BO and that a diversionary lane would be provided, the committee raised no objection to the proposed extinguishment, building upon and inclusion in site area of the existing lane for the development subject to the provision of a

diversionary lane.

(ii) Noting that the proposed diversionary lane was not required under the BO for the proposed development, the committee had no objection to the inclusion of the proposed diversionary lane in site area.

(e) <u>BCI 5 21/2013</u>

Issue : Validity period of modification / exemption.

Decision : Having considered the AP's justifications and the genuine technical

difficulty in obtaining the consent for the commencement of the relevant building works before the expiry of the two-year time limit,

the committee agreed to extend the validity period.

(f) BCI 6 21/2013

Issue : Tunnel building under a street.

Decision : Noting that there was no objection from relevant outside departments,

the committee agreed to grant an exemption under BO s31(1) to permit

the proposed tunnel to be built under a street.

(g) BCI 7 21/2013

Issue : Validity period of modification / exemption.

Decision : Having considered the AP's justifications and the genuine technical

difficulty in obtaining the consent for the commencement of the relevant building works before the expiry of the two-year time limit,

the committee agreed to extend the validity period.

(h) <u>BCI 8 21/2013</u>

Issue : Application for hotel concession.

Decision : Noting that the proposal generally complied with the criteria set out in

PNAP APP-40, and there was no objection from concerned departments, the committee agreed to the granting of hotel concession

under B(P)R 23A.
