## (a) MAI 1 23/2013

Issue : Application for hotel concession.

Decision : Noting that the proposal generally complied with the criteria set out in

PNAP APP-40, and there was no objection from concerned departments, the committee agreed to the granting of hotel concession

under B(P)R 23A.

## (b) <u>BCI 1 23/2013</u>

Issue : Validity period of modification / exemption.

Decision : Having considered the AP's justifications and the genuine technical

difficulty in obtaining the consent for the commencement of the relevant building works before the expiry of the two-year time limit,

the committee agreed to extend the validity period.

#### (c) <u>BCI 2 23/2013</u>

Issue : Revision in usage of dedicated areas.

Decision : Noting that the total dedicated areas would remain unchanged and the

bonus PR and SC granted for the existing development would not be affected, and that there were no adverse comments from relevant outside departments, the committee had no objection to the proposal.

change in circumstances for the relevant items of modifications /

vertical greenery from GFA and site coverage calculations.

projecting over a street.
