Decision : Noting from the document submitted by the AP that the owner had an

intention to enter into a landlord and tenant relationship with the

applicant, the committee accepted the proof.

(e) <u>BCII 5 9/2016</u>

Issue : Proof of realistic prospect of control of the land forming the site.

Decision : Noting that the land authority would grant the lease to the applicant

shown on the Form BA4 and Form BA5, the committee accepted the

proof of realistic prospect of control of the land forming the site.

(f) <u>BCII 6 9/2016</u>

Issue : Proof of ownership of the land forming the site.

Decision : Noting that the applicant was the registered lot owner according to the

LR record submitted by the AP, and that the owner's name tallied with that shown on the Form BA4 and Form BA5, the committee accepted

the proof.

(g) <u>BCII 7 9/2016</u>

Issue : Proof of realistic prospect of control of the land forming the site.

Issue : Proof of ownership and realistic prospect of the land forming the site.

LR record submitted by the AP and had accepted the offer for the proposed lease and would become the lessee of the land forming the site, and that the owner's name tallied with that shown on the Form

BA4 and Form BA5, the committee accepted the proof.

(j) <u>BCII 10 9/2016</u>

Issue : Proof of realistic prospect of control of the land forming the site.

Decision : Noting that the applicant shown on the Form BA4 and Form BA5 did

not have 100% ownership of the land forming the site, and the submitted documents did not demonstrate that the applicant had realistic prospect of control of the land forming the site to support the proposed development for compliance with the BO, the committee did not accept the proof and agreed that the plans should be disapproved.
