為註冊一般建築承建商及註冊專門承建商 申請註冊續期或將姓名或名稱重新記入名冊而設的 註冊承建商持續專業進修課程

本署現特告知,香港建造學院會繼續為有意申請註冊續期或將其姓名或名稱重新列入名冊的註冊一般建築承建商及註冊專門承建商在2023至2024年間提供註冊承建商持續專業進修課程。

- 2. 這項進修課程的目的,是向承建商講授建築業的最新發展,並會特別著重於與業界有關法例、守則、作業備考等知識。有關這項課程的資料單張及申請表格載於本函的附錄I。
- 3. 如《註冊承建商作業備考》38附錄J第2及14段所述,除下述的情況外,一般來說,註冊續期或將其姓名或名稱重新列入名冊申請毋須轉交予承建商註冊事務委員會進行面試及評審:
 - (a) 承建商在過往的註冊期內並無參與有關的建築工程(即未有就最少一項屬《註冊承建商作業備考》38附錄M第6及第7段所界定的相關建築工程提供工作證明);或
 - (b) 因有新的事件或情況出現而令該委員會須再就承建商是 否適合註冊一事進行審議。這些新近出現的事件或產生 的情況包括(但不限於)承建商涉及《註冊承建商作業備 考》38附錄J第2(b)段所訂的事項及符合《註冊承建商作 業備考》38附錄M 第1段規定的記錄。
- 4. 在受制於下文第5及6段所述的規限,如承建商沒有參與有關工程(即在過往的註冊期內未能就一項有關的建築工程取得令人滿意的工作經驗證明),只要他們能在遞交有關申請前的三年內修畢上述課程,並在申請註冊續期或將其姓名或名稱重新列入名冊時連同課程證書提交,便可能會獲豁免相關面試。

- 5. 承建商如在過往的註冊期內曾觸犯法例而被定罪、被紀律處分或被發展局或房屋委員會暫時禁止競投公共工程的註冊一般建築承建商及註冊專門承建商,即使他們已經修畢持續專業進修課程,在申請註冊續期或將其姓名或名稱重新列入名冊時仍須接受相關面試。
- 6. 承建商如沒有運用上述豁免面試的安排,在申請註冊續期或將其姓名或名稱重新列入名冊時曾接受面試而未能通過者,則他們在其後的申請,將不會獲當局批准豁免相關面試。
- 7. 請注意,香港建造學院所舉辦的持續專業進修課程會視乎實際報讀人數而決定班數,並保留酌情權決定因人數不足或在特殊情況下,取消有關的課程。如果香港建造學院取消有關課程,上述的豁免接受面試安排亦會自動取消。

Continuing Professional Development Course for Registered Contractors

註冊承建商持續專業進修課程

With reference to the requirements as stipulated in Practice Note for Registered Contractors 38 (PNRC 38) issued by the Buildings Department, the Building Authority would refer an application by a Registered General Building Contractor (RGBC) or a Registered Specialist Contractor (RSC) for renewal or restoration of registration to the Contractors Registration Committee (CRC) for interview and assessment if the contractor has been inactive in relevant building works in the past registration period.

Under such circumstances, HKIC has provided the Continuing Professional Development (CPD) course for RGBC and RSC who intended to apply for renewal or restoration of registration. The CPD course is aimed at updating the RGBC and RSC on the latest development of the building industry with particular reference to the legislation, codes of practice, practice notes, etc. Besides, BD has agreed that inactive contractors who do not have a satisfactory job reference on a relevant building project in the past registration period may be exempted from the requirement to attend an interview conducted by the CRC if they have completed the CPD course organised by HKIC not more than 3 years before the date of submission of the renewal or restoration application. However, RGBC and RSC who have conviction or disciplinary records, or have been suspended by the Development Bureau or the Housing Authority to tender for public works in the past registration period, will be required to attend an interview conducted by the CRC upon application for renewal or restoration of registration even if they have attended the CPD course.

For those who wish to apply as RGBC are required to attend all Module 1 sessions. For those who wish to apply as RSC are required to attend respective and related modules (Module 2 to Module 6) in addition to Module 1 as and when required.

根據屋宇署《註冊承建商作業備考》38 的規定,若註冊一般建築承建商註冊或專門承建商在過往的註冊期內,沒有參與《建築物條例》訂明的有關建築工程或公共工程,則建築事務監督會轉介其續期或將其姓名或名稱重新列入名冊的申請予承建商註冊事務委員會來進行面試及評審。

有見及此,香港建造學院現舉辦一個特別為註冊一般建築承建商及註冊專門承建商有意申請續期或將其姓名或名稱重新列入名冊而設的「註冊承建商持續專業進修課程」。藉此課程,本學院希望註冊一般建築承建商及註冊專門承建能更新其對建築業管制法例及作業備考的最新知識。同時,本學院經與屋宇署相討後,屋宇署已同意就那些在過去註冊期間沒有參與《建築物條例》訂明的有關建築工程或公共工程的註冊一般建築承建商及註冊專門承建,只要他們能在遞交有關申請前不多於三年修畢這課程,他們在申請續期或將其姓名或名稱重新列入名冊時便可獲豁免所需的面試。上述豁免安排並不適用於那些在過去註冊期內曾觸犯法例、被紀律處分或被停牌的註冊一般建築承建商及註冊專門承建,此等承建商在申請續期或將其姓名或名稱重新列入名冊時仍然須要接受面試。

註冊一般建築承建商須修讀單元 1 課程。註冊專門承建商須修讀單元 1 另須額外修讀單元 2 至單元 6 內適用於其註冊之專門工程單元。
