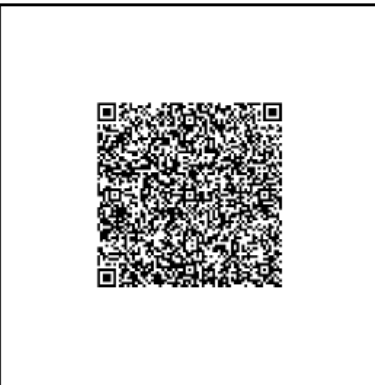

The Buildings Department has the right to charge a reasonable fee for the processing of any data access request.
